#### WILL MY SPONSORSHIP BE ACCEPTED?

The Commonwealth reserves the right to accept or reject any application for sponsorship. Sponsorship packages will generally be allocated to those organisations who apply earliest, however, allocation of sponsorship packages is at the discretion of the Commonwealth, whose decision will be final.

#### HOW WILL I KNOW IF MY SPONSORSHIP APPLICATION IS ACCEPTED?

You will receive written advice confirming your level of sponsorship and a tax invoice for the total amount will follow.

#### WHAT DOES 'NAMING RIGHTS' MEAN?

Gold sponsors will be acknowledged as "proudly supporting" an award category in the announcement of the award and on the trophy. Gold sponsors may be offered the opportunity to select an Award for naming rights, however, the final decision will rest with the Commonwealth.

A sponsor will not be offered naming rights for any Award for which they are a nominee.

The deadlines for delivery or supply of the sponsor's logo will be specified in the Sponsorship Agreement.
