The Prime Minister's Veterans' Employment Awards (the 'Awards') recognise the achievements of Australian organisations and individuals that make significant contributions to the employment of veterans, and partners of current and former serving Australian Defence Force (ADF) personnel.

The Awards are an initiative of the Prime Minister's Veterans' Employment Program, which seeks to increase employment opportunities for veterans and their partners by raising awareness of the skills, experience and attributes they bring to the civilian workplace.

2022 Award finalists will be featured via a range of communication channels to a diverse national audience. Finalists will be promoted in advance of a cocktail style Awards ceremony, to be held in Canberra, and will be complemented by additional promotion following the event.

## How do I apply for sponsorship?

## Will my sponsorship be accepted?

The Commonwealth reserves the right to accept or reject any application for sponsorship. Sponsorship packages will generally be allocated to those organisations who apply earliest, however, allocation of sponsorship packages is at the discretion of the Commonwealth, whose decision will be final.

## How will I know if my sponsorship application is accepted?

You will receive written advice confirming your level of sponsorship and a tax invoice for the total amount will follow.

## What does 'naming rights' mean?

Gold sponsors will be acknowledged as "proudly supporting" an award category in the announcement of the award and on the trophy. Gold sponsors may be offered the opportunity to select an Award for naming rights, however, the final decision will rest with the Commonwealth.

A sponsor will not be offered naming rights for any Award for which they are a nominee.

## When do I need to supply my logo or other materials

The deadlines and specifications for supply of the sponsor's logo and other material will be specified in the Sponsorship Agreement.
